**WINFORD CHARLES BLASINGAME, SANDRA BLASINGAME, HARRY FRANKLIN
BROOK AND TERRI LINN BROOK’S JOINDER TO STEPHEN TRIGO'S
OBJECTION TO CONFIRMATION OF JOINT PLAN OF REORGANIZATION**

COMES NOW Winford Charles Blasingame, Sandra Blasingame, Harry Franklin Brook and Terri Linn Brook (the “Claimants”), by and through their undersigned counsel, and files this joinder (the “Joinder”) to Stephen Trigo's Objection to Confirmation of Joint Plan of Reorganization at Docket No. 194 (the "Trigo Objection"). In support of this Joinder, the Claimants state as follows:

1. On March 3, 2009, the Claimants initiated an action against Sherwood Valve LLC (the “Debtor-Defendant”) and Engineered Controls International, Inc. (“ECII”)² in the United States District Court for the Northern District of Alabama (the “Alabama Action”) due to personal injuries suffered.

2. The Claimants’ Complaint alleged Alabama state law causes of action for (i) violation of the Alabama Extended Manufacturer’s Liability Doctrine; (ii) breach of warranty; (iii) wantonness; (iv) negligence and/or negligence per se; and (v) loss of consortium.

3. The Claimants hereby join in the objections to confirmation of the *Debtors’ Joint Plan of Reorganization of Taylor-Wharton International LLC and its Affiliated Debtors Under*


² ECII was subsequently dismissed from the Alabama Action with prejudice.


